- Use of donations and administration fees:
1. Earth Share Australia is paid up to 11 per cent of each donation by member organisations for the administration and promotion of workplace donation programs (fee level depends on the service provided to the recipient charity).
 2. Donations to Earth Share Australia are divided (less administration fee):
 - ◆ Fifty per cent equally among all members
 - ◆ Fifty per cent to a Special Initiatives Fund to be made available as grants to both member and non-member charities. This helps support smaller and regional charities and joint projects. Details of grants will be published by Earth Share Australia.
